The documents are part of the required submission. All submission shall follow the law and regulation in Malaysia.

Please touch base with local bank in Malaysia for clarity. All submission shall follow the law and regulation in Malaysia.

9.	What guarantees and recourse is RAC able to provide to the leasing entity?	The specific form of guarantee will be provided at a later stage, nonetheless RAC intends to protect the interest of all parties.
10.	Does RAC have any restriction on lease payments to non-Malaysian entities?	Lease payment will be made to local company.
11.	Is the budget for locomotive and wagon procurement already funded?	RAC will be responsible to secure the fund.
12.	Can we use our parent/ partner's/ JV records to fulfil paid up capital are below 10million?	Yes.
13.	At this time, we have not finalized our account for the financial year 2018. By the time the tender is called, our financial statement for year 2018 will be available to show our compliance with the minimum equity required. Could RAC confirm that we can be considered as meeting the financial capacity requirement for the purpose of the prequalification?	Yes.
14.	Is there a possibility to extend the submission date of the Pregualification?	The submission date is fixed on 28 June 2019.
15.	What is the anticipated timeline for RFP to be issued?	Target by Q4 2019.
16.	Is there any estimated time for the Pre-Q result to come out?	RAC will inform the result through our webpage and official channel.
17.	Can two (2) subsidiaries under the same group of company form two (2) different joint ventures respectively with two (2) different companies and submit two (2) Pre-qualification Applications?	Yes. Please explain the strategy and approach in the submission.
18.	Please clarify the definition of Joint Venture in Pre-Q document. Does the JV here only mean incorporated JV? Or unincorporated consortium can also be determined as a JV?	The way of the company forming the JV either incorporated or unincorporated is both acceptable. However the incorporation must be registered in Malaysia.
19.	If a foreign Original Equipment Manufacturer (OEM) is part of a JV. What is the minimum percentage (%) of local company share in a JV?	There is no minimum percentage (%) requirement set by RAC.

25.	In the instance tri-parties come together to bid for locomotives and/or wagons, however there is one prime with other two parties undersigning as witnesses, would that be acceptable to RAC?	Yes. However the role of each party must be explained.
26.	Can one manufacture collaborate with few bidders?	Yes.
27.	If the foreign company is a state-owned company. Which one box should be ticked in the Form B?	If the submission is not JV, please tick the 'Individual' box.
28.	Could you please provide the definition of "local content"?	Please refer to the definition made by relevant agencies, such as Malaysian Industry-Government Group for High Technology (MIGHT) and Technical Depository Agency (TDA).
29.	Could we consider the total life cycle cost as baseline for local content assessment?	Local content generally will be based on actual parts and equipment going into the rolling stock. However, we will consider all aspect during RFP.
30.	The local content in Pre-Q document for wagons is 50% and for locomotive is 40%.  Please clarify the definition and method of calculation for local content. Is the calculation method similar to the Industry Collaboration Program (ICP)?	Please refer to the definition made by relevant agencies, such as Malaysian Industry-Government Group for High Technology (MIGHT) and Technical Depository Agency (TDA).

	a) Based on our experience with many years of work in the brake industry is that many second quality brake manufacture as will claim that their brakes are compliant to UIC standards.	
	b) Our position is who is going to verify, authenticate or certify their claim is true or not?	
	c) UIC authorities in Europe will test and homogolate the brake equipment and will issue a certificate of UIC approval or compliance only if the brake passes their stringent testing. Once certified, they will endorse the name of the brake manufacturer in their website www.UIC.asso.fr which is updated yearly.	
	d) The list of approved manufacturer companies can be downloaded via their website www.UIC.asso.fr	
	We strongly suggest/request that since the brake is a safety critical equipment that this clause be amended to UIC certified or approved with certificate to be submitted as supporting document.

44.	This section states "DIESEL ENGINE Suitable for 4000-tonnes pull application." We need to understand what the balancing speed requirement is. Current blue tiger locomotive does 2500 T at speed of 90 KM/H and is capable of doing 4000T at approximately 75 KM/hr. Would this be acceptable?	The details will be provided during the RFP stage
45.	What is the ruling grade requirement? Could we use "1% ruling gradient with 160 metres radius uncompensated curves" from blue tiger contract?	The details will be provided during the RFP stage
46.	Based on RAC's demand projections, what is the expected locomotive and wagon volume in the forthcoming RFP?	RAC is looking at all available options, depending on capability of the Applicant. Section 6 (g) of the prequalification document outline the number of sets in general.
47.	What is the required delivery schedule for the first locomotive and wagon, and the remaining locomotives and wagons?	This is part of Section 6 to be filled by the Applicant.
48.	Would RAC team be interested in visiting and meeting existing customers globally who have successfully executed such localization projects?	Yes.
